**2. DECLARATIONS OF INTEREST:** - none declared.

**3. MINUTES OF THE PREVIOUS MEETING:** -

On a proposal by Cllr Hutton the minutes of the previous meeting held on 23<sup>rd</sup> June 2021 were approved as a true and fair record by all. There were no matters arising.

**4. PLANNING:** - Noted the decisions of the Council were as follows: -

**WW/21/00883/DOM** – Locks Ash, 32 Locksash Close.

**No objection subject to being incidental to the use of the main building.**

**WW/21/01869/DOM** – Fairfields, Cakeham road.

**No objection. Comment: The Council would wish existing greenery to remain.**

**WW/21/01972/DOM** – Little Hayes, meadow Lane.

**No objection subject to remaining incidental to the main dwelling.**

**WW/21/02002/DOM** – 1 Marine Drive West.

**No objection. Comment: The Council would like assurance that there is enough and drainage.**

**WW/21/02047/DOM** – Wix Corner, Redlands Lane

**More information requested.**

**WW/21/02099/DOM** – 4 Mill Gardens.

**Objection on the grounds that the extension is projecting beyond the street line.**

**WW/21/01884/DOM** – Launston, 15 Howard Avenue.

**No objection subject to use ancillary to the main dwelling.**

**Comment: The Parish Council are concerned that the side Dormer may be unneighbourly.**

**WW/21/02117/DOM** – Pelorus, Royce Way.

**No objection.**

**Comment:** Can construction traffic be required to park off the road.

**WW/21/01214/FUL** – Meadows Farm, Piggery hall Lane.

**No objection subject to license being obtained and the ditch being properly maintained.**

**WW/21/02278/DOM** – Moddershall, Elms Lane.

**Objection on the grounds of being out of character with the area which is a conservation area as described in Policy 30 of the Village Design Statement. The Parish Council were also concerned about the rear balcony being unneighbourly and also about light pollution to the rear**

**WW/21/02290/DOM** – Lindfields, Chichester Road.

**No objection.**

**WW/21/02203/DOM** – The Willows, Shipton green

**No objection subject to no trees or their roots being damaged during this work.**

**Comment.** There is no indication of plant housing or filtration associated with a pool in these plans.

**5. To receive the Planning Authority decisions of interest since the last meeting.**

The decisions of interest from CDC were received.

**6. Enforcement issues** – The Clerk reported that the high fence at the end of Ellanore Lane had been reduced in size. Councillors questioned the gates however which have remained high. The Clerk agreed to look into this. Cllr Martin enquired about access to information about current enforcement cases. The Clerk agreed to look into this.

**7. Correspondence and AOB** – Cllr Hutton requested that the Council consider applying for a Tree Preservation order (TPO) on an old tree in the grounds of 36 Marine Drive. The Planning Committee resolved that this would be progressed.
