- **(b) The Old Nursery** WW/ It was agreed that Mr Martin will attend the Chichester District Council Planning Committee on the 16<sup>th</sup> January for the item on the Old Nursery WW/18/01686
- **(c) Neighbourhood Plan update** –Noted that he Parish Council is awaiting a response from Chichester District Council to the scoping document submitted previously. There has been a good response from land owners confirming that sites were still available.
- (d) CDC Local Plan Review The working party on this topic met on Wednesday January 9<sup>th</sup> to consider the two papers from Chichester District Council, the Preferred Approach and the Sustainability Review. Mr Martin and Mrs Pike outlined the main findings from the working party which the Parish Council then considered. The full response will be entered onto the Chichester District Council website. The main areas of concern for Councillors were regarding the impact of development without the supporting infrastructure improvements such as highways, schools, sustainable transport and drainage. Any development should also adhere to the law embedded in the various designations awarded to the land within the Parish and the rest of the peninsula. Councillors also queried the land quality information within the report. Mr Hutton thanked Mrs Pike and Mr Martin for their detailed consideration of these documents.
- (e) Planning application 18/02708/DOM Dolphins, Rookwood—Councillors noted and were concerned that Chichester District Council had closed the enforcement decision on this site and that this may be an error in law. Mrs Pike commented that the Habitat Regulations do not appear to have been triggered in this application and this will be followed up.
- **91. CONFIRMATION OF MINUTES AND MATTERS ARISING** Subject to a proposal by Mr Martin to amend minute 81(1) to read "in this event there is an undertaking to recharge material and recharge East Head as a spit.", on a proposal by Mr Lewis and seconded by Mrs Pike, the minutes were approved and signed by the Chairman.
- **92. DISTRICT AND COUNTY COUNCIL UPDATE** –Cllr Hamilton reported that the draft plans for the Local Plan Review were available for all at Bracklesham Barn from 4.30pm to 8pm on Friday January 11<sup>th</sup> and also at East Pallant House.

- b) Footpaths and Open Spaces The Clerk reported an update on the purchase of land involving legal advice. On a proposal by Mr Martin, seconded by Mr Patel Members agreed to deal with this item in closed session.
  - Further to Mr Martin's concern about the future viability of the care of the Summerfield Road trees, the Clerk reported that the Summerfield Road Tree Planting Project, which is a community project that is planting fruit trees in the community, were aware of the need to ensure their longevity as a group in order to maintain a plan for the care and maintenance of the trees.
  - c) Sportsfield and Millennium Meadow Noted the Cricket Club plans for extending the Clubhouse will be considered at the next meeting.
  - d) Snowhill Mrs Pike reported that the finger post footpath sign has collapsed. The Clerk will contact the Harbour Conservancy to repair.
  - e) Finance The Budget Monitoring for December was circulated. The Clerk updated the Councillors on the latest situation regarding Barclays bank and reported that two Councillors plus the Chairman were required to sign the change mandate form so that the Clerk could then liaise directly with the bank on future options for online banking. .
