4. PLANNING: - Noted the decisions of the Council were as follows: -

WW/22/02957/TCA - Land north of 7 to 13 The Wad

WW/22/03103/TPA - Horseshoe Cottage Elms Ride.

No objection on condition that only the one branch that overhangs Summerheys is removed plus any dead wood and that the site is cleared of any cut branches and wood

WW/22/03125/TPA - Camber Court, Rookwood Lane

Objection on the grounds that felling one pine and substantially reducing the crown of the other will not "conserve and enhance" the natural beauty of the AONB. It is therefore contrary to the Chichester Harbour Conservancy's planning policies. The trees appear healthy and form a single canopy that hides the roof line of the property. They also shield the property from the immediately adjacent coastal footpath. The tree closer to the property has presumably been there for at least 40 years without apparent ill effect.

WW/23/00033/TCA - Summerheys. Elms Lane

No Objection subject to the proposed replanting being made a condition of approval.

WW/23 00044/DOM – Sea Dog, 4 Owers way
