- 2. DECLARATIONS OF INTEREST: None given.
- 3. MINUTES OF THE PREVIOUS MEETING: -

#### WW/23/02292/DOM – Willows, The Byeway.

Comment: The Village Design Statement of the WWPC Guideline 34 states that 'any new development should maintain the spaces between the buildings, the large plot size and use red brick or tile. Any new development should maintain the existing mature hedges and 3-4 m of grass verge to the road.' The Parish Council therefore feel that a preferred location for this store would be to the rear of the property as no other property in this cul de sac has any building to the front of the property and this would therefore be out of keeping with the area

#### WW/23/02308/FUL - 23 Marine Close.

#### WW/23/01883/FUL – 14 Ella Close further information.

Comment: Having considered the further information provided, the Parish Council withdraws its objection to these plans.

# WW/23/01781/FUL - briar Cottage, Meadow lane.

**Objection.** Further to the extra information provided, the arbiculturalist's report partially allayed the Parish Council's concerns about damage to trees from the new building, especially during construction. The several recommendations in the report need to be included in the planning conditions, if a permit were granted. Can the Planning Officer assure the Parish Council that all these

conditions will be enforced, especially the construction exclusion zone? All the other reasons the Parish Council gave for objecting still stand.

### WW/23/01991/DOM - South Nore, Snow Hill substitute plans.

The Parish Council were pleased to note the Pump House had been moved and is looking forward to seeing a further application for this aspect of the application. There is still great concern about the eventual positioning of the pump house.
