#### What's happening?

The government introduced the **Localism Act in 2011**. It gives residents more of a say in the development of their own parish. A key part of this is the **creation of a Neighbourhood Plan** by the local community and the Parish Council. This will set out what local residents consider important to preserve in our village and provide guidelines on the types of future development we would find acceptable.

#### Why is a Neighbourhood Plan important for West Wittering?

Once agreed, our Neighbourhood Plan has legal status. Future planning decisions for the parish will need to take into account the requirements agreed in our Neighbourhood Plan, for example:

- where new homes, shops and other developments will be built
- the design, layout and purpose of new and altered buildings.
- which green spaces, community assets and areas of local historic or cultural interest will be protected
