"IT IS RESOLVED that where the Parish Council is made aware of substitute plans in respect of a planning application that has already been considered by the Planning Committee the Clerk is hereby given delegated powers to respond to the Local Planning Authority on behalf of the Parish Council, in consultation with the Chairman of the Planning Committee, as follows:

- 1. Not to object where a previous objection by the Planning Committee is apparently addressed by the substitute plans, or
- 2. To reconfirm the previous response by the Planning Committee (for or against) where the substitute plans are apparently immaterial, or
- 3. To seek an extension of time to allow the Planning Committee to reconsider the planning application where the substitute plans appear material.

The determination of whether substitute plans represent a material change to a planning application shall be decided at the sole discretion of the Clerk pursuant to these delegated powers. The Clerk shall be free to consult with Members before making a response to the Local Planning Authority."

- **6.** To approve the Neighbourhood Plan for submission to CDC for legal checks and examination.
- 7. To confirm the date of the Annual Parish Assembly as May 26th, 2022 and agree a date of June 9th for the June meeting of the Parish Council as the usual date clashes with the Queen's Platinum Jubilee Bank Holiday.
